## **2"VAT and VRT on transactions involving Motor Vehicles**

December 25th, 2019 - Motor vehicles sold in Ireland are liable to Value Added Tax VAT at the standard rate In addition when a motor vehicle is being registered in Ireland it is liable to Vehicle Registration Tax VRT The rate of VRT varies between vehicle types and is mainly dependent on the level of CO2 emissions VRT is payable on new unregistered'

## **'Importation of Personal and Household Effects and Private**

**November 6th, 2019 - A person bringing a vehicle from abroad must notify Customs of the importation of the vehicle as removal goods immediately upon arrival in Finland irrespective of whether the person is arriving from within or from outside the EU The vehicle may be used in Finland only if a declaration of use has been submitted to Customs'**
